Terms and Conditions:

- 1) To note that except where the said Program is cancelled by the Organizer, there shall be **NO** refund for the cancellation by the Sponsor upon signing for the said Program.
- 2) In consideration of the aforesaid sum, the Sponsor shall be entitled to all the items as stated in **Appendix 1**.
- 3) Booking and/or appointment for the photo shoot shall be subject to the schedule and availability of the photographer and/or make-up artist and/or hairstylist.
- 4) **EXCEPT** due to the fault or negligence of the photographer or where the photographer is unable to attend the scheduled photo shoot on a mutually agreed date, the Sponsor is **NOT** allowed to ask for postponement or change in the date for the photo shoot unless the Organizer has consented to it and the Sponsor is agreeable to pay the additional charges imposed by the Organizer, as penalty for deferment of the proposed photo shoot.
- 5) **SUBJECT ALWAYS** to additional payment being made by the Sponsor to the Organizer and/or upon mutual agreement by both parties hereto, request for reshoot on another date will **NOT** be entertained after the completion of the photo shoot and any dissatisfaction shall forthwith be communicated to the photographer during the photo shoot.
- 6) There shall be **NO** dispute by the Sponsor merely on the basis of dissatisfaction of the service provided by the Organizer or the photographer or the make-up artist or hairstylist under the said Program or not meeting the Sponsor's expectations.
- 7) The Sponsor **SHALL** at all times be responsible for the wellbeing and safety of the Sponsor's pet during or after the photo shooting session. If necessary, the pet is to be on a leash.
- 8) The Sponsor hereby expressly **UNDERTAKE** to clean up the faeces and urine left behind by the Sponsor's pet during the photo shoot and to compensate and remedy the Organizer or any third party for any damage caused to any property or injury caused to any person by the Sponsor's pet and the Sponsor shall further **UNDERTAKE** to **INDEMNIFY** and keep the Organizer fully and continuously **INDEMNIFIED** against all costs and expenses, loss or damage that the Organizer may incur or suffer arising from any incident(s) or action(s) that may arise due to the Sponsor's negligence in taking care of the Payee's pet during the photo shoot.

- 9) The Sponsor **AGREES** to bear all the related costs and expenses including but not limited to the Organizer's make-up artist's or hairstylist's or photographer's travelling expenses should the Payee wish to have the photo shoot at any other location.
- 10) The Organizer reserves the right at the Organizer's sole absolute discretion to amend and/or revise the terms herein without prior notice and/or to cancel the said Program without assigning any reason whatsoever and/or to discontinue and terminate the Organizer's service under the said Program if the Sponsor fails to comply with any of the terms contained herein.
- 11) The Organizer has the exclusive right to use the photos for publicity purposes.
- 12) The Organizer **DOES NOT** warrant the service provided by the Organizer's photographer and/or make-up artist under the said Program and the Organizer shall not be liable or responsible for any non-performance of the service by the photographer and/or make-up artist.
- 13) The Organizer **DISCLAIMS** all representations and warranties with respect to any of the service(s) provided by the photographer and/or make-up artist under the said Program, whether expressed or implied, oral or written.
- 14) To the extent permissible by applicable laws, the Organizer **SHALL NOT** be liable for any consequential, special or punitive damages incurred or suffered by the Sponsor due to breach of duty, or negligence, or inaction or default of the photographer and/or make-up artist.
